## BOOKING RESTRICTIONS

We do not accept one-night bookings. Bookings can be for either 2 nights or 4 nights only.



#### ARRIVAL AND REGISTRATION

Check-in time is 9am - 11am. Please contact rallycamping@swanagerailway. co.uk if you are going to be earlier or later on your scheduled arrival day.





Latest departure time is 10am. Any guests that do not vacate by this time will automatically incur a late departure fee.

No refunds will be granted in the event of early departure.



Please note, we cannot guarantee to allocate specific pitches or to pitch groups together. Motorbikes vehicles are only accepted at the discretion of the management.



#### WEATHER

In the event of serious weather conditions, we may offer a tow off site service which is at your own risk. You should check that your insurance cover will allow secondary towing.

## FORCE MAJEURE

## BAD BEHAVIOUR

Large groups of any kind can be intimidating to others. Please consider and respect the enjoyment of other campers at all times.

Bad behaviour from any member(s) of a group may result in the entire group being asked to terminate their stay. No refunds will be granted in the event of early departure.





## Roads to Rail - Corfe Castle CAMPING RULES 2021



Please adhere to our site rules at all times. General bad or inappropriate behaviour will not be tolerated.

NOISE- The noise curfew is 24:00- by which time all radios, TVs and car engines must be muted. Loud parties are not acceptable on site at any time.

All farm buildings, barns, sheds are strictly out of bounds. We treat wilful misuse, damage, destruction of property seriously and offenders will be asked to terminate their stay.

The campsite is on private property and you must respect all other signage.

We expect our staff to be treated with respect and consideration at all times.



## The speed limit across the entire site including access

entire site including access roads is 5mph at all times. We operate a zero-tolerance

policy regarding dangerous driving and offenders will be asked to terminate their stay.

Please avoid excessive and unnecessary use of vehicles on site, particularly driving to and from the facilities, especially after 22:00 or when the ground is wet.



Barbeque's are not permitted under any circumstances.





Parents or guardians are wholly responsible for the behaviour of children and minors in their care at all times. Children are expected to remain on the campsite fields unless accompanied by an adult.

Children are not permitted to congregate and play in any of the facilities on site.

FACILITIES – Children under 10 years old must be supervised by a responsible adult at all times whilst using any on-site facilities.

**CYCLING** – Children are not permitted to ride bicycles anywhere on site unless they are proficient in cycling as if off road. Using the farmyard and access tracks as riding circuits is not permitted. Please ensure bicycles are left in the designated bike racks so as not to cause obstruction or inconvenience to others.

# ANIMAL SAFETY

Dogs are welcome on site but we ask they are kept on a lead at all times and are not permitted to roam freely. You should not leave pets unattended on site at any time; animals can get very distressed in unfamiliar environments.

Please ensure you clean up after your dog - bins are provided.

FARM ANIMALS – Under no circumstances should farm animals be harassed or chased. Please do not feed the animals, even if you think the food is suitable for themunrestricted diets can cause serious health problems.



#### PITCHING

FIRE SAFETY - Fire safety regulations stipulate that there must be a 6-metre gap between each unit. Any unit that we consider to be pitched incorrectly will be asked to move.

Please pitch in front of the central to allow maximum space between you and your neighbour. Please keep everything including vehicles and windbreaks within the boundary pitch and avoid using our posts to anchor tents or washing lines. Washing of units, boats or equipment on site is not permitted.



**RECYCLING** – Please be diligent when disposing of your waste and separate general waste, food, dry mixed recycling and glass into the correct bins provided.

FOOD WASTE – Do not throw away any food waste or containers into the hedges or undergrowth- please use the designated bins provided.

WASTE WATER – All waste water and chemical waste must be collected in a suitable container and disposed of correctly at one of our drain points.

> The owners will not accept any liability in respect of any person, or the property of any person using the site.

> The campsite is on a working farm in a very rural area. Please always follow the Countryside Code.

The campsite and surrounding areas are private property and the management always reserve the right of entry.

Any person wilfully disregarding these rules risks being asked to leave the site.
